OVERLOADING/OVERFILLING CONTAINERS:

I understand that a container is considered full when the material is level with the sidewall of the container, and that I may not load anything into the container that protrudes outside of the four walls of the container. I further understand that I may not load the containers in excess of Federal DOT weight limits. CIR drivers reserve the right to refuse to haul any container that is overweight, and if the container is hauled, I understand that I am responsible for any over-weight fines that are incurred. _____

COMMERCIAL ROLL OFF TERMS AND CONDITIONS

GENERAL REFUSE, CONCRETE, AND WOOD CHARGES:

The disposal rates outlined above will be charged to the credit card on file at the time of the request; not at the time of the haul. If the charge does not go through, or we are unable to collect payment, the container will not be serviced. Any additional fees (overweight fees, rental fees) and all wood recycling fees will be charged to the credit card on file within 24 hours of the container service. Itemized invoices will be sent at the end of each month unless otherwise indicated.

RECYCLING CONTAINERS:

If the haul fee exceeds the value of the rebate of the material being recycled, this excess charge will be billed to the credit card on file within 24 hours of the container service. If the material being recycled does not meet quality standards or is contaminated, the container will be billed as General Refuse to the credit card on file. For specific quality standards, please contact us at 719.390.9500.

CONTAINER SERVICE STANDARDS:

Our roll off operating hours are Monday through Friday, 8:00AM to 3:00PM. With the exception of periods of inclement weather, all service requests, Monday through Friday, will be serviced within one business day, unless otherwise specified. Requests made on Saturday or Sunday will be processed the following Monday.

OVER-LOADING, OVER-FILLING, AND OVERWEIGHT CONTAINERS:

Over-filling, over-loading, and overweight containers pose serious safety concerns. A container is considered full when the material is at or below the sidewalls of the container. Our drivers cannot legally haul a container that is over-full, over-loaded, or overweight and will refuse service until you have corrected the issue, which may incur additional rental fees. A container is also considered over-full if the material is packed too tightly into the container. Concrete, dirt, roof gravel, asphalt, and wood roofing shingles require special handling because of the weight. Make sure that the loads are spread evenly in the container and the container is only loaded three (3) feet deep. The weight of any waste material placed in the container may not exceed 10 tons (blue roll off truck) or 5 tons (white roll off truck), depending on the truck that is designated to haul the container. In the event a container is found to exceed legal weight limits set forth by Colorado Department of Transportation and the Federal Motor Carrier Safety Administration, any fines assessed by these agencies will be billed immediately to the credit card on file in addition to the overweight fees assessed by Colorado Industrial Recycling.

CONTAINER ACCESSIBILITY:

All containers must have four (4) feet of clear access around the sides and rear of the container as well as twenty-five (25) feet of clearance from the front of the container for it to be serviced. If the container is not accessible, you will be billed \$150.00 for the trip, and additional rental fees may apply until the issue is corrected and the container becomes accessible.

PROHIBITED ITEMS:

The following material may not be placed into any container provided: materials containing asbestos, PCB(s) or PCB materials, sealed units/tanks, CFC(s), HCFC(s), and/or substitute refrigerants and gases, gasoline, fuels, oils, antifreeze, sealed drums or barrels, explosive materials, pyrotechnic devices, firearms or munitions, compressed gas cylinders, nickel-cadmium batteries, nickel metal hydride batteries, lithium batteries, alkaline batteries, televisions, computer monitors, electronic waste, tires, mercury switches, radioactive material, liquids of any kind, or any other hazardous material. Plastics, plywood, pressed wood, painted wood, and tree branches are allowable for our General Refuse Disposal service, but are prohibited for any of our recycling services.

DAMAGE TO ROLL OFF CONTAINERS:

Once a container has been placed, **do not move it**. Damages to the containers, whether by moving them or by loading them, will be billed at a rate of \$50.00 per hour plus the cost of material.

LIABILITY:

Colorado Industrial Recycling is not liable for damages done to items placed on or around the container, as well as the property the container is placed on, to include any asphalt or concrete roadway.
